Child Care is Workforce Development
Child Care is Economic Development



The child care reality of the North Country

- Child care slots are vanishing at a greater rate than they are being created.
- The lack of affordable, accessible, quality child care limits individuals' access to employment.
 - Women and minorities have been affected the most by child care closures
 - This contributes to increased poverty in the North Country.



The cost of child care is prohibitive

- In the North Country, it costs families \$15,000/year for child care.
- The living wage in the North Country is \$22/hour.
- People cannot afford to work and pay for child care.



Low paying jobs =
lack of schedule flexibility

Employees are often faced with two options:

- Choose to resign
- Get fired for absenteeism



The solution is creating a child care pipeline

- Enable individuals to join or rejoin the workplace
 - Counteracts poverty
 - Supports working families who still don't earn a living wage.
 - Creates wealth
 - Benefits communities



Funding a child care pipeline = supporting workforce and economic development

- Help with job creation
 - Home child care services
 - Increase tax base for counties & communities
 - 80-120 new slots will increase tax base by \$500,000-\$750,000 annually per county.
 - Represents a return on investment of 400% over 3 years per county.

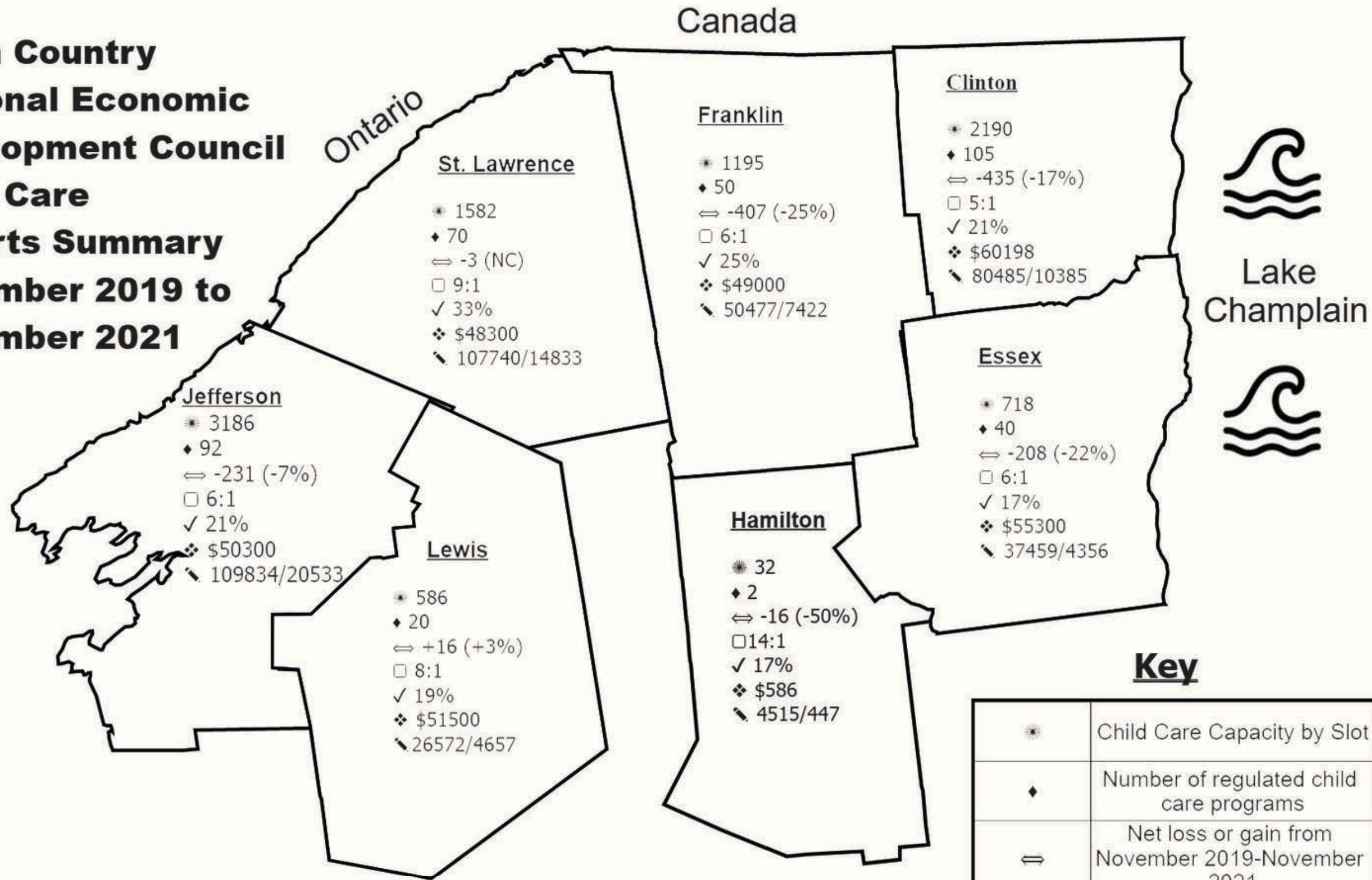

North Country Regional Economic Development Council Child Care Deserts Summary November 2019 to November 2021



Recommendations to stabilize the child care crisis in the North Country:

1. Create and implement an early childhood workforce pipeline at each county level for the development of new child care programs, beginning with home-based family child care programs and school-age child care programs.
2. Campaign widely to increase awareness in the community (including the business and education community) of importance of high-quality child care.
3. Subsidize the child care system from both ends - parent tuition and provider expenses - to achieve affordability, stability and sustainability. Increase NYSOCFS Child Care Market Rates.

What is a Child Care Desert?

- It's a census term that means there are 3 or more children vying for 1 regulated child care slot in any given census tract.
- In the Adirondacks, there are 53 census tracts and of this number, 40 are child care deserts.
- We have lost 20-25% of our regulated child care capacity in the last 2 years.
- We have gone from nearly 5,000 regulated slots to 4,100 regulated slots
- We have over 22,000 children under the age of 13 vying for these 4,100 child care slots.



Solution:

Build the Child Care Pipeline

- Marketing Campaign touting Family Child Care as a career
- Startup support to become a Registered Family Child Care Provider
- Business & Recordkeeping training
- Provide pre-service training to prospective family child care providers
- Purchase initial equipment, supplies, and furnishings
- Minor home renovations (railings, fences, exit window if needed)



Predicted Pipeline Results

- Each new Registered Family Child Care Home would create 8 new slots.
- Each new Licensed Group Family Child Care Home would create 16 new slots.
- 5 of each of these in one year in each county would net 360 new slots!
- Over 3 years we could create 1080 new slots each in Clinton, Essex, and Franklin counties!



Investing in the Child Care Pipeline

- For each county, an annual investment of \$100,000/year is needed
- 3-year project
- \$50K for personnel line and \$50K for non-personnel (supplies, equipment, furnishings, pre-service training)
- Small Business Development Center will provide business development "bootcamp"
- Opportunities to leverage private foundation, state, and federal funds.





Essex County Child Care Pipeline

- Leading the way
- Adirondack Community Action Programs (ACAP) and Essex County government are working on a project
- Using ARPA funds
- Lack of child care options identified as county government employment issue
- Details of the project





Clinton and Franklin County Pipeline

- Child Care Coordinating Council of the North Country seeks funding.
- Glens Falls National Bank has awarded \$10,000 for our three counties.
- Would like to replicate Essex County project.



Return on Investment

- Career development and small business startup
- Current labor shortage- begins to solve this from both sides
- Child care increases employee productivity- lost productivity costs \$57B in the USA each year
- Support economic recovery- every \$1 invested in child care yields \$1.86 in return
- It's the right thing to do—

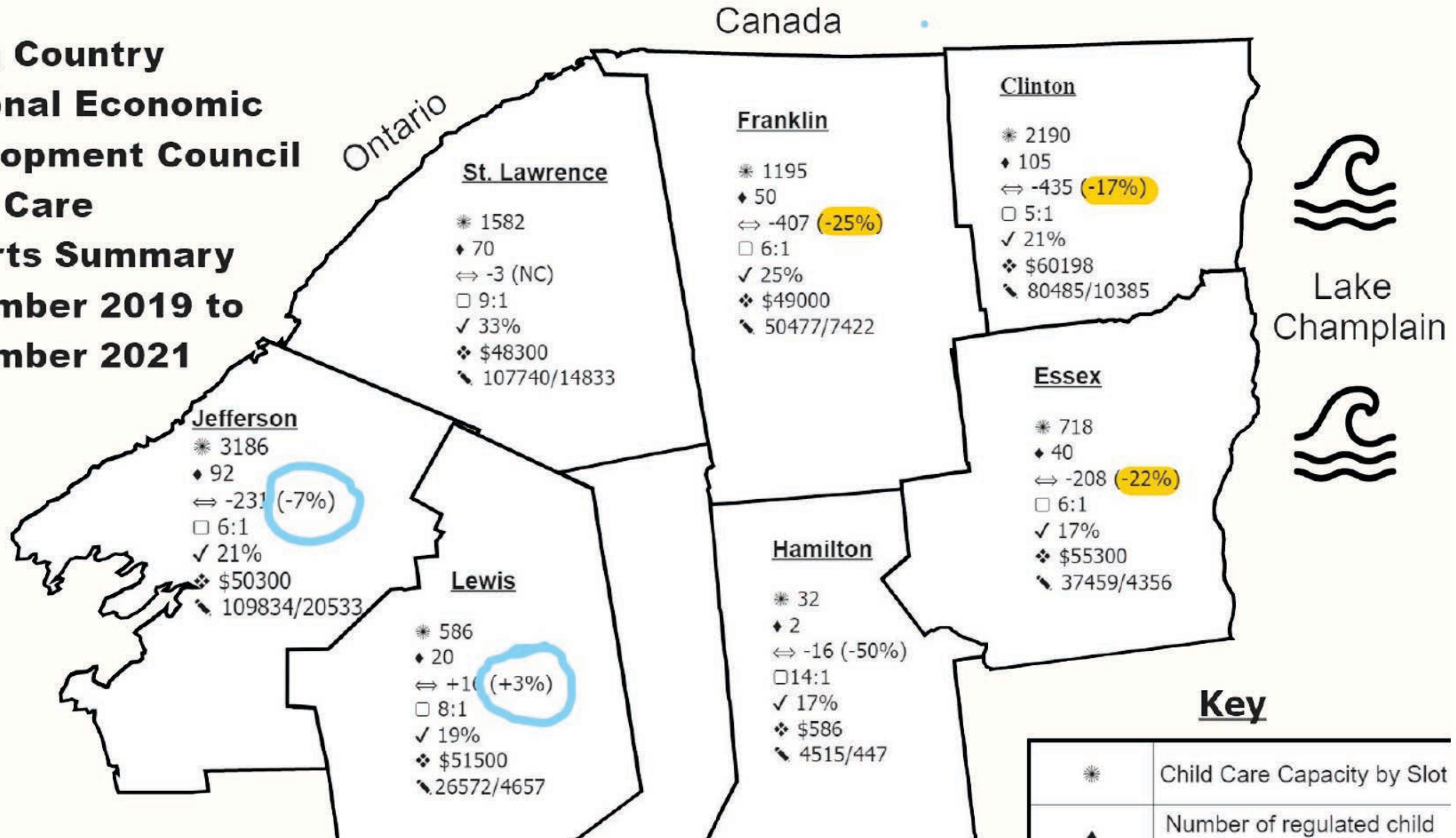

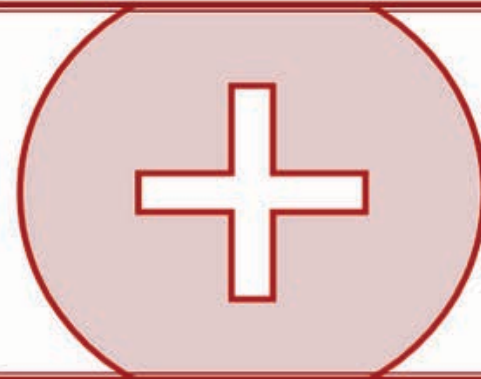


Why support child care training and education?

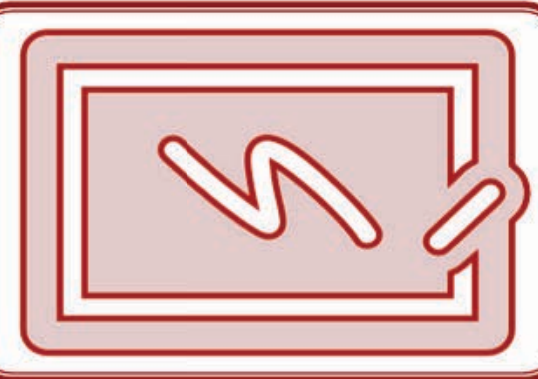
- Labor Shortage
 - IDA and WDB report employers struggle with recruiting and retaining a qualified workforce
- Childcare desert
 - In Lewis County, there are 7.8 children for each regulated childcare slot available and 94% of the county is considered a childcare desert.
 - Rural community cannot support a Child Care Center



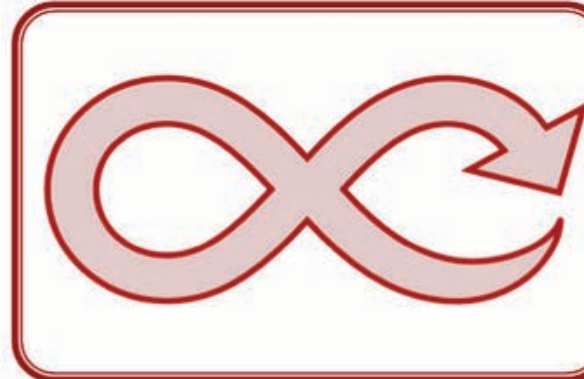

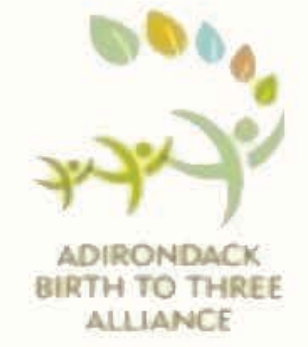

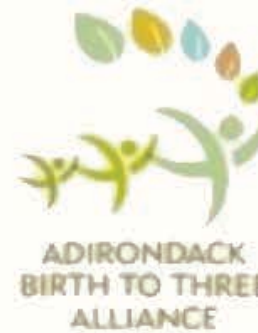
